

For example, if a firm participates as single firm in one package and as JV partner in another package. Please clarify?	Consulting firm may apply in more than one package as per information provided in the REOI. Please also refer to section 3.20 of World Bank's Procurement Regulations which is reproduced herewith: <i>"A Consultant shall not submit more than one Proposal, either individually or as a joint venture partner in another Proposal. If a Consultant, including a joint venture partner, submits or participates in more than one Proposal, all such Proposals shall be disqualified. However, this does not preclude a firm's participation as a sub-consultant, or an individual's participation as a team member, in more than one Proposal when circumstances justify and if permitted by the request for proposals document"</i>
3	Advertisement (Short listing Criteria) Clause 1.1,1.2,2.1,2.2, 2.3 It is not mentioned the number of projects required to obtain the full marks against each sub-clause. Please specify the number of projects for each sub-clause for obtaining full marks?	Marks shall be given according to the Criteria prescribed in the REOI. Short listing criteria 1.1 and 1.2 are obvious in nature whereas in 2.1, 2.2 and 2.3, each sub-criteria has been assigned specific marks. The firm may provide supporting document to prove experience in underline sectors as mentioned in the sub-criteria and where required, the number of assignments/projects have been mentioned in REOI document.






