Meeting with USAID Team

Mr. Paul Lundberg. Democracy & Local Governance Advisor and Mr. Saeed Ashraf Siddiqui, DG Assistance Specialist of USAID visited PMDFC on 23rd June, 2010 in connection with its upcoming Municipal Service Delivery Support Project in southern Puniab. They were briefed about the infrastructure development and institutional development activities undertaken by the PMDFC during the last four years and expertise acquired in different areas. Mr. Paul Lundberg observed that PMDFC was contacted keeping in view the fact that at present it was the only organization which had undertaken the activities in municipal sector in Punjab on lines on which USAID also intended to move. Later on the USAID team briefed the Board of Directors of PMDFC during 60th BOD meeting held on 25th June, 2010 on USAID upcoming Project and proposed to associate PMDFC in its implementation. Board approved the proposal in principle. It was decided that further modalities would be worked out with USAID team and would be placed before the Board for approval.

Combined visit of Asian Development Bank and PMDFC

John Leonardo of Asian Development Bank and Syed Tanawar, consultant of ADB, visited the office of PMDFC where a detailed demonstration of Computerized Financial Management System (CFMS), developed by PMDFC, was given to them. John appreciated CFMS and PMDFC's expertise. He was told that PMDFC had already established CFMS in 34 TMAs. John wished to arrange a field visit of the consultant of ADB along with the concerned professionals of PMDFC so that ADB could verify the viability of replication of CFMS of PMDFC to its partner TMA as a pilot.

A field visit of ADB and PMDFC was conducted on May 18, 2010 to TMA Sarai Alamgeer in which Mr. Tanawar represented ADB, and PMDFC was represented by Mr. Shazad Khan Sherwani GM (F&A), and Mr. Nauman Akhtar Manager (F&A). This visit was made to assess the working of CFMS. During the visit, Mr. Tanawar took first hand information from TMA staff about the usefulness of the CFMS. Actual data entry and extraction of report from the CFMS was also observed and print outs of the following reports were taken:

Cash Book, Establishment Check Register, Contingency Check Register, classified Abstract, Bank Reconciliation The consultant of ADB left the TMA with appreciation of implementation of CFMS by PMDFC.

Delivery of Hardware for FMS

During the fourth quarter of FY 2009-10, PMDFC successfully completed the delivery of computers, printers and UPS to year 2 TMAs for FMS. While providing computers to the TMA, PMDFC assured the proper logging of above said assets in the property registers of TMA and then onward its issuance to finance wing of TMAs as dedicated for CFMS only. TMA Staff was retrained to use computers and accessories effectively.


