(Rehabilitation of Municipal Infrastructure)

Infrastructure Development subprojects are being executed in 16 Program MCs under PforR component of the Punjab Cities Program. Out of 48 Nos Rehabilitation subproject initiated in the year 2020-21, 47 No subprojects have been completed, remaining 1 project will also be completed by January. Machinery & Equipment for Solid Waste Management

The Program MCs were facing acute problems in the management of solid waste due to non-availability of efficient and modern machinery. PMDFC prepared PC-I for procurement of modern and efficient machinery and equipment for each MC by assessing presently available machinery and equipment and the future requirement of each MC which were approved and the procurement of this machinery and equipment is in progress. The superstructures in most of these chassis have been fabricated and are in use by the MCs all subprojects will be completed by March, 2023.



Upcoming Subprojects of PCP

Consultants for Sectoral Planning and Detailed Design were hired at the end of March, 2022 and work has been taken up in all the Program MCs. The Sectoral Plans are being prepared in the sectors of water supply, sewerage, solid waste management and urban roads. The detailed design of the subprojects is being carried out in the sectors of water supply, sewerage, storm water drainage, roads, parks, street lights and general bus stands. So far PC-Is for 27 projects costing Rs 4274 million have been approved and work on one subproject has commenced already. Seven subprojects costing Rs 1295 million are under approval with the various forums and PC-I of 03 subprojects costing Rs 1900 million have been sent to MCs for review. It is anticipated that subprojects with total cost of Rs 14000 million will be got approved by the end of February, 2023 and the work on some of the subprojects will be started by end of January, 2023.

The World Bank Mid-term Review of Punjab Cities Program

A Mid-term review of Punjab Cities Program was conducted from 28 Nov to 12 Dec 2022. In this regard, various sessions were held at PMDFC head office, Lahore. The purpose was to review the progress of Sub Project Prioritization and Sector Plans, Environment and Social Management Initiatives and Institutional Strengthening activities being performed in 16 partner MCs under Punjab Cities Program. Various consulting firms briefed the World Bank team about the progress









of their assignments and accomplishment of tasks. IS team presented progress on program DLIs, communication strategy and other initiatives.

Workshop on Environmental & Social Management Framework

A workshop on Environment and Social Management Framework under Punjab Cities Program (PCP) was organized by ESM Team at RAMADA Hotel, Gulberg, Lahore on 11 and 12 October 2022. World Bank ESM Technical Mission, Consulting Firms working on various infrastructure projects under PCP and MC Staff from 16 PCP Cities attended the workshop. Followed by a meeting at the PMDFC head office to discuss E&S Management and other relevant issues.

The firm will prepare a comprehensive report on factors like demographic profile of each city, growth of working age population and employment distribution. Furthermore, the firm will create provincial level economic plans to integrate the economies of 16 PCP cities. Revitalization of Waste Water Ponds

Grievance Redress Management (GRM)

PMDFC is striving to improve the MCs' service delivery by redressing the complaints/ grievances of the citizens efficiently. For the purpose Complaint Tracking System (CTS) had been introduced during PMSIP (Punjab Municipal Services Improvement Project) funded by World Bank. The system is being strengthened under Punjab Cities Program by transforming CTS into Grievance Redress Management (GRM) to facilitate the citizens to register their complaints online using Android/ iOS Application. In this context, "Baldia Shikayaat" app has been developed to facilitate citizens for registering municipal services complaints/grievances. Citizens can also register their grievances arising from any infrastructure projects being implemented under PCP.
