The document will be sent by air mail/courier on payment of an extra amount of PKR.1, 000/- or equivalent amount in USD and may also be collected in person. - The last date of submission of bids shall be October 22, 2020 by 1100 hours and shall be opened on same day at 1130 hours. Late bids shall be rejected.
